Will of John PEASE 1795

In the name of God I John PEASE of Hutton Hang in the parish of Beadale and County of York Yeoman do make this my last will and testament in the manner and form following, that is to say, I order and direct that all my just debts legacies and funeral expenses be well and truly paid by my executor hereinafter named

I give and bequeath unto my dear wife Dorithy PEASE the sum of fifteen pounds per year to be paid by my executor during the time my farm is held in lease or leases under the Rt Honble the Earl of Ailesbury and no longer And my said wife Dorithy PEASE to live rent free in the house and to choose a room for herself I also order that she shall have all my household furniture at her own free will and dispose I likewise give unto my wife the sum of ten pounds to be paid immediately after my decease by my executor hereinafter mentioned

I give and bequeath unto my son Thomas PEASE in the parish of Danby Wisk the sum of thirty pounds also to my son John PEASE of Thirnby in the parish of Spenithorn the sum of thirty pounds

I also give to my son Joseph PEASE now in London two hundred ~~and fifty~~ pounds

Likewise I give unto my daughter Mary HOPS wife of Ralph HOPS of Binsoe in the parish of Tanfield the sum of sixty pounds

I likewise give unto my daughter Jane PEASE now in Scotland the sum of one hundred pounds

Likewise I give unto my daughter Dorithy MILNER wife of Samuel MILNER grocer in Middleham the sum of fifty pounds

Also I give unto my daughter Elizabeth MUDD of Middleham widow the sum of fifty pounds but my will and mind is if the said Elizabeth Mudd marry with Archibel MA COLLA cordwainer in Middleham then my desire is that she shall have only one guinea

I likewise give unto my youngest daughter Ann PEASE now living with me the sum of one hundred pounds

I likewise give unto my grandson Pease MUDD son of my daughter Elizth MUDD the sum of ten pounds all which said mentioned legacies to be paid twelve

months after my decease by my executor hereafter named

Also I give devise and bequeath unto my son William PEASE now living with ne all my personal property whatsoever and wheresoever and growing and arising upon the premises stock crop &c All my securities for money whatsoever (excepting a Roan Galloway, which my desire is that mt daughter Ann PEASE should have, being promised by me)

Also I give unto my son William PEASE the farm I hold under lease from the Right Honble the Earl of Ailesbury and lastly I do hereby revoke and make void all former wills by me made and of this my present last will and testament do make ordain constitute and appoint my said son William PEASE sole executor of this my last will and testament to see the same be duly performed

In Witness whereof I the said John PEASE have hereunto subscribed and set my hand and seal this fifteenth day of June in the year of Our Lord one thousand seven hundred and ninety five
