Serendipity!! (cont)

- Limerick Standard 31 May 1839
- Deaths: In William Street, this day, Edward HOMAN Esq. He was for many years engaged in the pawnbroking business and evidenced a soundness of judgement and clearness of faculties in his examination before the Parliamentary Committee to enquire into that system in the year 1837. His manner was kind and unassuming and his conduct that of a faithful friend.

This provides an opportunity to explore the parliamentary papers

- What can we do with this obscure reference
- Look at the CD-ROM index
- After a few tries I found the right search for pawnbroking
- There were a couple of entries that looked promising the best was:
- Select Committee on Pawnbroking in Ireland
- 1837-38 Volume 17 p173
- A quick trip to the stack to check. Then order

What was there?

- Several pages of evidence with interesting facts of genealogical nature.
- He was in business in Limerick for 30 years
- He was in business in Cork for six years
- He was representing the pawnbrokers of Limerick
- See photocopy

Lets refresh on what might appear in this useful resource

- Lots of things end up in parliamentary papers not just the reports of high ranking officials
- The National Library has a good collection (not perfect)
- They include:
 - ►lists of people
 - **▶** evidence
 - **▶**reports

Examples — names' lists

- Names of all persons admitted to the Dublin Trade Guilds apothecaries, Bakers... Smiths merchants — 1792 – 1837

- Account of sums received in Public Offices under fees due on demise of crown
